- Treasurers report approved.
- Guest, Craig Klinker, spoke with the board concerning the condition of the website. He will update the website, which he estimated will take only a few hours. We will use "word press" to make changes to the site more easily. The goal is to simplify and streamline the site. Carmen Wilkes will be the board liaison for this project. Craig agreed to submit an invoice for the project, but he is willing to do the work pro bono for the PHCA.
- Water adjudication ballots. The board agreed that the goal is to mail out the water adjudication ballot by March 21st. Homeowners will return the ballot by mail or bring the ballot to the meeting on 4/16/14. A signature is required on each ballot. An envelope is enclosed. No postage will be provided due to cost.
- Fire drill. Cathy met with Einar Jensen regarding the community fire drill. Einar has a lot of information, which will be distributed in the form of an E blast. It will include upcoming dates for fire drills, information regarding tax deductions for fire preparedness and more. Douglas County Sheriffs will also be involved in the drill. The date of the drill is tentatively set for June or July. The goal will be to have the date finalized by 4/16/14. We will provide the site and phone number for homeowners to set-up "reverse 9-1-1" on their home/cell phones. The information will be placed in the agenda or on a flyer at the annual meeting 4/16. It was recommended that "Dumpster Day" be moved to date before fire season, such as June. We will investigate the possibility of getting grant money to facilitate having 2 dumpster days.
