- 4) Fire-Preparedness
 - Build on topic presented at 2012 annual meeting, help educate new residents.
- 7. Brief Oil Update provided by Joel Lambe. Matt Sura has resigned from his Water Legal Group and is opening his own firm with a nonexclusive focus on oil and water suits. He has been working on a COGCC panel to draft oil related rules. A preliminary draft regulation would establish a setback requirement of 500 ft for both urban and rural areas. This draft regulation would require an opt-in by county and notification of affected property owners. Set Back near schools would be 1000ft. Other regulations to monitor air and water contamination and to set visual abatement and fire prevention rules are also in draft form (A draft regulation means that the language has been set and we are outside the public comment period. The regulations are now set for debate and in-house approval with COGCC).
