2. Treasurers' Report

a. Checking balance \$3,185.32

b. Savings \$2,654.91

- 3. Dumpster Day
 - a. Income/Expenses
 - i. Total payments \$955
 - 1. Expected bills Chipper \$1000.00, Dumpster \$1675.00, Donuts \$14.58
 - 2. Net expected payout \$1,734.58
 - 3. Remaining budget until after dues come in next year \$1,450.74
 - Annual meeting expenses, Holiday mailbox contest, Dues mailer, Q3 and Q4 Newsletter printing for snailmails
 - b. Review and Lessons Learned
 - i. Dumpsters were full by 10:30 due to large contributors such as multiple mattresses in one load.
 - ii. Chipper pile was so huge that they had to stay until 1:30 to process everything

- iii. Partially decomposed pine needles and pine cones required shoveling into a barrel to dispose of. This should have been bagged and put in dumpster
- iv. Plenty of abusers with extreme loads
- v. Metal was not cleared until Monday and abusers arrived to dump non metal all day Sunday.
- vi. Suggestions to discuss at annual meeting
 - 1. Dues increase to \$40 per year

 - 4. All second loads \$30
 - 5. Limit the size of a load to the average pickup bed
 - 6. No signage only eblast notification of event
 - 7. Limit the number of mattresses allowed
 - 8. Don't take a vote only ask for ideas
