HOT WEATHER IS HERE!!

We are in for what may be an exceptionally hot and dry summer. Fire and Water are the two issues that are foremost on my mind.

A Stage One Fire Ban is in effect for all of Douglas County for the entire summer. This means no open fires, and no fireworks. I want to thank the residents of Ponderosa Hills for their adherence to the No Fireworks Ban this year. This was so very important and thankfully we had no reported violators and no reported fire incidents. Great Job!

We still need to be vigilant about the open fire ban. In past years we have had residents who have burned in barrels or pits. This year please refrain and use Dumpster Day to get rid of unwanted yard and tree debris. Your first load is free with your paid membership. More about Dumpster Day on later pages.

Water use. We all share the water in the aquifers below us. These aquifers are labeled as nonrenewable. That means they are not renewed by ground water runoff. Historical data however has shown that they do renew somewhat from ground water but only very slowly. Bottom line – our water should be treated as a finite resource and used wisely and sparingly. Please don't waste water and don't over water. Blue grass is not a good choice for yards out here. Think prairie not suburban yard.



Committee Reports

Roads

The Civic Association developed a survey and solicited input from residents about the traffic and safety issues they were experiencing on our major intersections. We received less than 10 responses in total, but the overwhelming concern was the Ponderosa and Pine intersection. We will plan on opening the survey for comment again in the fall when school traffic picks up. The purpose of the survey was to gather data which could be submitted to the County in an effort to get some action taken to improve these intersections: Inspiration and Lost Canyon, Pine and Pine, and Ponderosa and Pine. The County informed us last spring that these were not dangerous intersections because there had been no increase in reported accidents. We felt they were misunderstanding the large number of near accidents at these intersections.

If these are areas of concern for you please join the Roads committee.

<u>Dumpster Day</u> August 11. 8:30 to 11:30

Annually PHCA members are offered the opportunity to get rid of trash, tree slash, and to recycle metal items. Members' first load is covered by their annual membership fee.

This year residents who have not paid their membership by June 30 will be charged a \$50 membership fee for the rest of the year which will include the first load at dumpster day.

A load is considered the equivalent of what can be loaded into a pickup bed. Additional loads may be allowed if there is space and will incur an additional **\$50 charge** per load. **PHCA Board reserves the right to turn away any items or loads they consider unacceptable or excessive.**

Certain items cannot be accepted by the dumpster providers. Below is the list. If these items are discovered in the loads or in the dumpsters PHCA will be subject to fines and additional charges.

Metal Recycling on Dumpster Day

Our Metal recycler on Dumpster Day is Matt's Maintenance. He will recycle items that are substantially metal. Metal appliances are also accepted. Electronic items are NOT accepted.

Slash Items on Dumpster Day

Matt's Maintenance is also providing the chipper on Dumpster Day. Logs up to 10" in diameter are acceptable. Dirt is NOT acceptable. Also the slash must be free of metal, cement, nails or other items that are none organic and could damage the chipper. You must plan to do your own unloading and must stay with the load until it has been chipped. Last year we had a great many abusers so the rules will be must stricter this year. You will not be allowed to just dump and leave.

General Household Recycling Guidelines

<u>The Garbage Man</u>, one of the garbage and recycling providers to Ponderosa Hills, has kindly provided some recycling guidelines.

Plastics – number 1-7 are
acceptable. Plastic containers that
have held anything other than
water must be thoroughly rinsed
out.
Glass – bottles, jars, etc. must be
rinsed out. Caps should be
removed
Please NO food matter.

Removing the paper labels on cans and bottles is requested but not required. No separating is necessary; you may combine all of the above for easy single stream recycling. Materials may be loose in any size container or bagged in clear or blue recycle bags.
